Bills so poorly written there would also be unintended consequences to other unassociated groups not targeted by these hate filled bills, SB 115, 370, 388, 401 and 12 with its sister bill in the House HB 3251.

If nothing else comes out of it the Millennium Diggers and the Willamette Valley Mining Associations should be very proud. ACTON ALERT!

At this point two anti-mining bills have been introduced into committee SB 401 and a new re-write SB 838. Both will have the effect of destroying or at least curtailing suction dredge mining in Oregon. We are putting a concerted effort by the mining community to address our legislators.

Writing to your legislators is of utmost importance, whether by calling, emails or regular mail. Let's flood them with protest! Let your State Senators and Representatives know if you are their constituents! That will grant you priority above those that are not. Title the letter with the Senate Bill #, requesting their opposition. Using your own words, let them know how the bill affects you as a miner and urge them to oppose each bill, writing a separate email for each Senate Bill. Important: don't forget to include your name and address and asked that your letter be included in the public testimony.

The Senate Bills are listed below, with talking points to use as a guide:

SB 838 (**Previously SB 115**)

- * Prohibits placer mining in Oregon using any form of motorized Equipment.
- * Prohibits any and all dredging in the state of Oregon.
- * A maximum of one year in prison and a \$6,250 fine or both.
- * SB 838 is a taking of all of your mining rights.
- * SB 838 is a preemption of the Federal Mining Law.
- * SB 838 will cause state wide takings litigation by miners against the state of Oregon.
- * The enormous cost to the state defending SB 838 will be prohibitive.

SB 401

- * Wild and Scenic creek and river designations prohibit all mining.
- Covers all designated waters beds and banks.
- * Also a setback of 1/4 of a mile on each side above high water mark is an outright taking of Federal mining rights, guaranteed under the law.
- * SB 401 will create massive takings litigation by miners over the 1/4 mile set back.
- * SB 401 would stop or curtail most building on private lands.
- * SB 401 targets most streams in Oregon that are gold bearing.
- * SB 401 is an overt act by the Oregon Legislature to destroy mining and miners in Oregon.

At a time when Oregon is trying to recover and produce jobs this is a major jobs killing bill.

These Senate Bills will kill placer mining in Oregon. It should make you very angry that the environmentalists and their cohorts in the state legislature would do this to us.

<u>HB 3251 (Same as SB 12):</u> Has completed public testimony and is scheduled for a Work Session by the House Committee on *Agriculture and Natural Resources*. You have until the committee convenes Monday at 3pm to send in written testimony. This bill would prohibit the gross weight of all vehicles to not exceed 200lbs. When we all know that the average weight of an ATV starts at 500lbs!

SB 370 and SB 388 have not been scheduled for a committee hearing as of this newsletter. I will keep you posted through the Diggers email if I find anything out.
